Feedback summary

Feedback on the overall structure and content of the new plan was overwhelmingly positive.

Strong sentiment that Council should commit to ambitious climate and biodiversity leadership and acknowledgement of the importance of partnerships.

Protection and regeneration of our natural environment was identified as the highest priority by more than half of respondents.

Recognition of progress since the Council declared a climate and ecological emergency in 2019.

Better links to Council's other plans such as the District Plan, Spatial Plan and Waste Management & Minimisation Plan.



How your feedback is reflected in the final plan

CAT MANAGEMENT	This action has been incorporated in the plan and staff will work through a process to appropriately identify the most effective and practical solutions for our district.
PREDATOR CONTROL	We have included stoats as a key predator and will support the expansion of predator control and biodiversity monitoring.
WILDING CONIFER CONTROL	We have added the Whakatipu Wilding Conifer Control Group and aligned with wildfire mitigation strategies under the broader biodiversity and resilience programmes.
TRANSPORT AND ACTIVE TRAVEL	The plan has been aligned with current programmes across the district and action 6.2 updated to highlight the importance of active travel.
BUILT ENVIRONMENT	We have incorporated reference to how other councils have incentivised green building standards and clearly defined the community work programmes underway in the stormwater space.
URBAN PLANNING & GROWTH	We are required by Central Government to plan for growth and increased housing demand. Our Spatial Plan and District Plan guide this growth while also protecting the environment and reducing emissions, by supporting better transport and land use outcomes. Our 30 Year Infrastructure Strategy also integrates future-focused planning to reduce emissions, protect biodiversity, enhance resilience, and provide for the needs of our district. In the CBP we have added a new action to protect indigenous biodiversity through planning policy.
WASTE REDUCTION & CIRCULAR ECONOMY	We have added cross references to organic waste and construction waste actions in the Waste Management & Minimisation Plan.
REPORTING & COMMUNICATION ENHANCEMENTS	The plan introduces a stronger strategic framework for monitoring and accountability, embedding public facing metrics to measure how well the district is progressing towards its strategic outcomes.
OTHER	We have included reference to deliberative democracy practices under 'Local Partnerships'. A snapshot of the whole plan has been presented at the front of the document, with a summary including timeframes and indicative budgets at the end of the document.

Implementation of 50 Actions with Budgets and Timelines

QLDC has committed to rolling out 50 actions across seven outcome areas over the next three years. These actions are mapped with indicative budgets and implementation timelines and delivered through QLDC's Annual Plan and Long-Term Plan.
